Individuals, families, organizations, or businesses that wish to have use of any fields or facilities or hold an event at the Village of Sloatsburg Community Field, **MUST** obtain a permit 4 weeks in advance. This includes, but not limited to the following:

- Assembly of 15 or more people
- Bus Groups
- Sports Leagues
- Special Events

Parks Available for Group Rental:

- Sloatsburg Community Fields
- Sloatsburg Community Pavilion
- Basketball Court
- Tennis Courts
- Passive Park
- Pool Gazebo (pool season pass holders only)

*\*Group use and busses are **prohibited** from all other Village Parks\**

For groups wishing to visit and utilize the Village of Sloatsburg Community Field, playgrounds, sports fields, and facilities, a permit is required. All forms are downloadable from the village website at [www.sloatsburgny.com](http://www.sloatsburgny.com) or can be obtained from visiting the village office located at 96 Orange Turnpike. Completed form(s) must be sent to [Recreation@sloatsburgny.com](mailto:Recreation@sloatsburgny.com), along with any questions regarding rental fees, insurance requirements and security deposits.

The enforcement of these rules and regulations will be by the Police Department of the Town of Ramapo, by any other peace officers having jurisdiction, and by such special personnel as may from time to time be authorized by the Board of trustees of the Village of Sloatsburg. No person shall fail, neglect, or refuse to comply with or obey the lawful direction or command of any member of the Ramapo Police Department, personnel of the Village or other duly authorized personnel, or fail, neglect, or refuse to comply with or obey an instruction, direction, regulation, warning or prohibition in any park or other recreational facility.

## GENERAL USAGE GUIDELINES

- Equipment and facilities designed for obvious and common usage shall be put to such commonly intended use and none other. Non-intended uses are prohibited if they may occasion damage or excessive wear or inhibit others from using the facility as intended.
- Permits for group or team usages will be issued to a responsible official or representative of the team or group. The permittee will be held responsible for the conduct of the group.
- Users must leave facilities in as good a condition of repair and as originally found.
- No person shall kindle, build, maintain or in any way use a fire except in fireplaces, or in self-supporting barbecue grills or stoves in places designated as picnic areas.
- Picnicking without fire may be done in any area not otherwise prohibited where it will not interfere with other recreational activities.
- No team games or any kind of organized athletics is permitted except in areas provided for the same.
- Dogs, cats, and other household pets shall not be brought into the parks unless on a leash and under the supervision and direct control of the owner. No such animals may be allowed to run freely in the park. No person shall allow any animal in his custody to discharge fecal matter in any park, and if same does occur, shall remove same immediately.
- No person shall leave any trash, garbage, or debris upon park property. All trash is to be deposited in trash containers where available. Where containers are not available, trash is to be removed from the park.
- All persons shall so comport themselves as to enjoy the facilities without detracting or restricting the enjoyment by others also legally entitled to be there. Rowdy and boisterous behavior is prohibited.
- No parents, guardians or custodians or any minor, shall permit or allow him or her to do any act which would constitute a violation of these rules and regulations.
- No person shall injure, deface, disturb, defoul not in any manner destroy or cause to be destroyed any part of any park or any facility, building, sign, structure, equipment, utility, or other property found therein. No person shall dig for, remove, injure, or destroy any tree, flower, shrub, plant or growing thing, or any rock, mineral, artifact or other material within the boundaries of any park. No person shall kill, trap, hunt, pursue or in any manner disturb or cause to be disturbed any wild bird, snake, or animal within the boundaries of any park.
- No person shall drink or possess beer, wine, or other intoxicating substances within or on any Village owned building, facility, or park area.
